Section – A

GENERAL CONDITIONS

1. The qualifications, emoluments and conditions of service, shall be as prescribed by the University.
2. The prescribed essential qualifications and experiences are the minimum as laid down in **Section 'B'** of this advertisement.
3. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview. The University shall shortlist the candidates on the basis of qualifications and experiences.
4. The University may conduct examination/seminar/presentation/written test/ computer test as a method for further short listing of candidates for interview as decided by the competent authority.
5. The University reserves the right to modify/withdraw/cancel any communication made to the candidate(s) at any stage without assigning any reason.
6. Those already employed should apply through proper channel. However, they may submit an advance copy to meet the deadline set for receiving the application.
7. The University reserves the right to:
 - i. Draw panel for future appointment in the event of occurrence of a vacancy caused by non-joining of candidate within the stipulated time or where a candidate joins but resigns or dies within a period of a year from the date of joining;
 - ii. Not to fill up the advertised post, without assigning any reason.
 - iii. Reduce or increase the number of post.
 - iv. Decide criteria/ procedure for short listing of the candidates.
 - v. Relax minimum requirements of qualification and/or experience on the recommendation of the Screening/Selection Committee.
 - vi. Extend the last date of receipt of the Applications.
8. Qualifications and experiences will be reckoned as on last date of submission of application. Application fees once paid shall not be refunded under any circumstances.
9. Application received after the last date or incomplete in any respect shall not be considered.
10. The University shall verify the antecedents or documents submitted by a candidate at any time, at the time of interview or during the tenure of the service. In case it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine antecedents/ background and has suppressed the said information, his/her services shall be terminated.
11. In case of any dispute/ambiguity that may occur in the process of Selection, the decision of the University shall be final.
