Section -A

GENERAL CONDITIONS FOR NON-TEACHING POST

1. The qualification, emoluments and conditions of service, including age of superannuation, shall be as prescribed by the UGC/University/Government of Bihar as amended from time to time.
2. The prescribed essential qualifications and experience are the minimum as laid down in **Section 'B'** of this advertisement.
3. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for interview. The University shall shortlist the candidates on the basis of qualification and experience.
4. The University may conduct examination/seminar/presentation/written test/ computer test as a method for further short listing of candidates for interview as decided by the competent authority.
5. The University reserves the right to modify/withdraw/cancel any communication made to the candidate(s) at any stage without assigning any reason.
6. Those already employed should apply thorough proper channel. However, they may submit an advance copy to meet the deadline set for receiving the application.
7. The University reserves the right to:
 - i. Draw panel(s) for future appointment(s) in the event of occurrence of a vacancy caused by non-joining of candidate(s) within the stipulated time or where a candidate joins but resigns or dies within a period of a year from the date of joining;
 - ii. Not to fill up the advertised posts, without assigning any reason.
 - iii. Reduce or increase the number of posts.
 - iv. Decide criteria/ procedure for short listing of the candidates.
 - v. Relax minimum requirements of qualification and/or experience on the recommendation of the Screening/Selection Committee.
 - vi. Extend the last date of receipt of the application.
8. Relaxation in educational qualifications, experience, age, etc. to the reserved category candidates will be permissible as per rules of the Government of Bihar.
9. Candidates belonging to SC category must submit appropriate certificates issued by the competent authority recently. In the case of OBC/EBC reservations, certificate should be issued from competent authority, particularly with reference to Non-creamy layer. Those who fail to submit the required certificate(s) will be treated as General Category, subject to fulfilment of other terms & conditions.
10. Experience and qualification will be reckoned as on last date of submission of application. Application fees once paid shall not be refunded under any circumstances.
11. Application received after the last date or incomplete in any respect shall not be considered.
