Sealed tenders are invited in 2-Bid systems (Technical Bid & Financial Bid) from reputed and experienced firms for supply of 40 (Forty) Fire Resistant Compaction Almirah. The bidders are required to read the tender documents carefully and ensure compliance with all instructions herein. Non-compliance with instructions in documents will disqualify the bidders from the tender process. Incomplete tenders, amendments and additions to tender after submission or tenders received after due date are liable to be ignored and rejected.

2HOUR FIRE RESISTANT COMPACTOR WITH BIS LABEL TECHNICAL SPECIFICATION

- OEM/Authorized dealer offering products should be ISO 9001:2015, ISO 14001. These Certifications are mandatory.
- The department will procure fire resisting mobile compactors only.
- Bidder must have successfully supplied fire resistant compactor in the past five year. Copy of work order must be attached.
- Every compactor body should have double face cabinets with double back, to optimally utilize the available storage space.
- Inner dimensions for one body should be 1600 H *660W s860
- Shelf should be 1.00mm
- Total 4 compartments for per cabinet.
- The storage shelves should have minimum load bearing capacity of 70-90 K.g uniformly distributed load per shelf.
- The shelves should be adjustable.
- Sizes in Millimeters as per BI5 specifications to be supplied.
- Fire resistant compactor to be supplied by the vendor will essentially be as per IS14203. Product to be used in construction of the compactors has to be equivalent to BIS label Fire Resisting record protection cabinets.
- OEM should have BIS license for Fire resisting record protection cabinets having 120Min fire resistance
- Vendor shall provide computation of no. of files that can be stored with the proposed compactor arrangement.
- The locking mechanism for door should be 4 ways (Left, Right, Top, Bottom)
- Lock Supplied shall be dual control key lock (Two Control Key Lock) with option of providing Mechanical or Electronic combinations locks.
- Compactors shall be fitted with safety guard preventing the compactor units moving away from the rail and proper braking mechanism preventing reverse collision of mobile units.
- The guide track should be provided with an end stopper to avoid derailment of the units.

- Each Compactors unit at the drive wheel face shall be provided with the label holders.
- Undercarriage should have construction in welded frame made of HR sheet 3.15 mm thick conforming to IS:10748
- Handles: High Quality Polyurethane (PU) with three attractive arms/steel star wheel type.
- Paints: cabinets to be provided with Grey Color RAL 7024 and bodies should be provided with blue
- Super POL P.U. RAL -7044. Alternatively color shades to suit the Customers interiors.

A General Terms and Conditions:
